AN ATHLETE MAY RECEIVE ATHLETIC SUPENSION OR EXPULSION FROM THE TEAM IF THE RULES PERTAINING TO PRIVATE VEHICLES ARE VIOLATED. EXPULSION WOULD ONLY RESULT FROM REPEATED FLAGRANT VIOLATIONS.

PARENTS MAY DRIVE ONLY THEIR OWN CHILD AND MAY NOT USE THIS FORM TO RELEASE THEIR OWN CHILD TO RIDE WITH ANOTHER ADULT.

AN ATHLETE MAY NOT RIDE PRIVATE VEHICLES TO OR FROM AN ATHLETIC CONTEST. TO BE ELIGIBLE TO COMPETE THEY MUST HAVE WRITTEN PERMISSION FROM THE PRINCIPAL AND/OR ATHLETIC DIRECTOR **PRIOR** TO DOING SO. OTHERWISE, ARRIVING AT AN AWAY CONTEST BY PRIVATE VEHICLE WILL RESULT IN THE YOUNGSTER HAVING THE STATUS OF STUDENT SPECTATOR, NOT TEAM MEMBER. THEY WILL NOT COMPETE OR SIT WITH THE TEAM.
